Central Committee Minutes

7/15/2021 – Teleconference

The monthly meeting of the Democratic Party of Lane County Central Committee, held via teleconference, on Thursday evening, July 15, 2021 was called to order at forty-nine past six pm, Mr. Wig being in the Chair and noting a quorum and Ms. Swenson Harris present as Secretary.

The agenda was adopted as presented.

The minutes were approved as presented.

The Treasurer's report was received. The Party had \$1,815.46 in income and \$5,669.23 in expenses for the month, for a net loss of \$3,853.77.

The Campaign Services Committee reported on candidate recruitment for the 2022 election.

The Community Action Committee reported on the Party's Lane County Fair, Asian Celebration, and Pride Booths.

The Fundraising Committee reported that the Chili Cook Off will be held on August 29. Planning is ongoing for the Roosevelt Gala, the Committee continues to request auction donations.

The Organization Committee reported on the neighborhood leader program. The Committee has created neighborhood leader and PCP fliers to distribute at events. An IT subcommittee has been created.

House District 8 reported on the district's participation in the Chili Cook Off. Sean Shivers has been appointed as a Vice Chair for the House District.

House District 9 reported that the Florence Democrats Annual Picnic will be held on August 8.

House District 11 reported that district will hold a house party in September and

that organizing for the neighborhood leader program continues.

House District 12 reported on planning for the District's Chili Cook Off entry.

House District 13 reported on organizing for the fall election.

House District 14 reported that Mary Lou Vignola has been elected Co-Chair of the district. The House District will hold an event on July 26.

The Subcommittee for PCPs reported the names one person requesting nomination for the position of Precinct Committee Person: Joey Kranitz, nominated by Ms. Swenson Harris.

The Subcommittee for PCPs reported the names of previous nominees requesting to be appointed to the position of Precinct Committee Person: Gabii LeGatte, Brianna Camp, and Steve Coatsworth were appointed.

The PR Committee reported on Neighborhood Leader Program and Precinct Committee Person fliers for distribution at events. The Committee sent a press re-

lease to highlight accomplishments from the 2021 legislative session.

The Rules Committee reported on upcoming bylaw changes to accommodate changes to the State Party's Platform Convention timeline. The Committee met to consider changes and will notice a bylaws amendment for the September Central Committee Meeting. A Rules Committee meeting will be held on August 18.

The State Central Committee Delegation reported that the SCC will meet on June 27 to elect regional delegates to the State Party Executive Committee. The SCC will meet in person on September 11 and 12. The State Platform Convention will be held on December 10 and 11 in Happy Valley.

The 4th Congressional District Delegation reported that the Congressional District Committee will meet on July 18. The Lane County Delegation will meet to elect a Delegation Chair and Vice Chair.

The Office Committee reported that an office open house will be scheduled over the summer.

Upon unanimous consent, the Chair adjourned the meeting at forty seven minutes past seven o'clock.
