

DEMOCRATIC PARTY OF LANE COUNTY

CENTRAL COMMITTEE MINUTES

10/16/2014 – UO Lokey Education Complex, Rm 276

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the UO Lokey Education Building in Room 276 on Thursday evening, October 16, 2014, was called to order at eighteen minutes past 7 P.M., Ms. Fahey being in the Chair and noting the absence of a quorum, and Ms. Swenson-Harris present as Secretary. The Vice Chair was instructed to take measures to obtain a quorum.

The Treasurer's Report was received. The Party had \$7,379 in income and \$4,485.55 in expenses during the previous month, with a net difference of \$2,893.56.

The Budget Committee reported that the year-to-date expenses have been \$21,789 and year-to-date income has been \$22,582.53, giving the Party a net gain of \$793.54 for fiscal year 2014.

The Campaign Services Committee reported that ballots have been sent out and that volunteers are needed to call voters and encourage them to turn in their ballots. A GOTV kickoff will be held on Saturday, October 18th at 10A.M. at the DPLC office with Senator Ron Wyden.

The Publicity Committee reported that the committee is continuing their work to publicize the activities of the various campaigns and

Party committees. The Committee sends out a weekly email to notify subscribers of upcoming events.

The Community Action Committee reported that the committee participated in extensive voter registration efforts, helping to register over 600 people. The Party will be sponsoring a table at CALC's yearly event on October 25th from 5P.M. to 8P.M.

The Fundraising Committee reported that recent direct mail efforts have been very successful and that volunteers are needed to stuff more envelopes.

The Rules Committee reported that a set of rules for the Organizational Meeting will be presented at the November Central Committee Meeting.

The SCC Delegation reported that there will be an SCC meeting in December, delegates are encouraged to attend.

At forty six minutes past 7 P.M the Vice Chair notified the Committee of the presence of a quorum.

The previous minutes were approved as distributed.

The Organization Subcommittee for PCPs reported the names of two people requesting nomination for the position of Precinct

Committee person: Isabella Rassouli, who was nominated by Mr. Edmunson and seconded; and Maya Robbins, who was nominated by Mr. Edmunson and seconded. Spencer Christiansen, James Geocaris, Donald St. Clair, Hillary Murrieta, Therasa Fiora Starchild-Wolf, Tessa Ladnow, and John Landon were appointed, nominated by Mr. Smith and seconded by Mr. Schneider.

Mr. Wig moved to increase the Campaign Services Committee budget by \$10,000 to accommodate the expenditure of money raised to hire paid canvassers. The motion was seconded by Ms. Stecker and passed unanimously

Upon unanimous consent, the Chair adjourned the meeting at one minute past eight o'clock.
