### JENNIFER YEH EUGENE CITY COUNCIL, WARD 4



Not everyone is fortunate to live in the town they chose so I'm thankful I am able to raise my family here. I moved to Eugene to attend the University of Oregon and quickly fell in love with the tree-lined streets, fun local shops, and numerous cultural activities. When people ask me why I love Eugene I tell them it's because this is where the people I care about are, and because I meet so many people willing to put the effort into making it a better place.

My highest priorities going into the next term center around three issues; housing, our climate recovery efforts and DEI.

**Housing.** As with the changes made to allow ADUs, our process to implement HB2001 is giving us the opportunity to use our land use code to make space for more people rather than to keep them out as it has been used in the past. By creating opportunities and incentivizing denser and smaller housing types we can

create more housing that is lower in costs and fits different needs. I am committed to pushing to go beyond the minimum required by HB2001 as has been shown to be supported by our community, and just makes sense as our population grows. Additionally I will continue to support funding for subsidized affordable housing projects in our community and using our Housing Implementation Pipeline target the funds we do have to these goals that stretch from emergency temporary shelters to market rate homes.

Climate Recovery. Perhaps the biggest issue we are currently facing is how our local community can make meaningful efforts toward climate recovery. As we've seen in our CAP 2.0, this work is connected to many other efforts in our community including, housing, transportation, parks, urban forest, parking and more. I will focus on transportation spending that centers on the importance of climate recovery by prioritizing active transportation, public transit and electric vehicle adoption. I will continue to support the Moving Ahead project and the expansion of infrastructure improvements that include the needs for biking, walking, driving and transit on our major corridors. These improvements can support not only our transportation goals, reduce single-driver trips and support the needs of affordable housing communities on these key corridors.

**Diversity, Equity and Inclusion.** Through all of this work I'm committed to continue to make sure diversity, equity and inclusion is integrated into our processes. I am especially interested in finding ways to make our community engagement and board and commissions more diverse and inclusive. This is not a box we can check, but work that needs to be done with intention ongoing. Some engagement has been happening for some time and continues toward true inclusion, while other efforts to reach communities we serve are just beginning. I will support staff in this effort and ensure we are adequately funding these efforts. If we aren't meeting the needs of all the communities we serve and if we aren't truly inclusive we're failing our entire community.

## GREG EVANS EUGENE CITY COUNCIL, WARD 6



Please accept my request for the endorsement of the Democratic Party of Lane County for the office of Eugene City Council for Ward 6 (Bethel/Northwest Eugene). This statement is created to address the critical issues facing the Bethel area and the City of Eugene. In my view and experience there are three chronic issues challenging the health and welfare of the citizens of my ward and the city as a whole. I have been and continue to be an activist for the underrepresented and underserved communities in Eugene since moving here in 1986.

For the past 22 years my family have been homeowners in the Bethel area. I have lived in South Eugene, West Eugene, River Road, Whiteaker and Bethel neighborhoods during the more than 36 years I have resided in Eugene. I

have five children, four of my children have been raised in Eugene and have attended Eugene 4j and Bethel Schools. I have been a volunteer and office holder in the NAACP Eugene/Springfield Branch and past president of the Washington/Oregon Conference of NAACP Branches. I served on the Lane County Fair Board of Directors; the Eugene Planning Commission; the National Council on Black American Affairs for the American Association of Community Colleges; Lane Transit District Board of Directors; the National League of Cities Board of Directors and Chair of the Transportation and Infrastructure Committee, 2017; League of Oregon Cities, President 2019.

I have been actively involved in youth activities including coaching for Kidsports, the Eugene YMCA, and founding member of Emerald Valley Little League. I am the founder and former director of the Rites of Passage programs for underrepresented and underserved youth focusing on African American, Asian Pacific Islander, Latino/Latina, and Native American protected class communities at Lane Community College. In my private consulting practice, my client list includes: the Springfield School District; the Lane County Sheriff's Reserve Academy; the Bethel School District; Northwest Christian University; Lane County Department of Youth Services; and the Education Superhighway.

In 2013, I was appointed to the vacant Eugene City Council Ward 6 position. I was subsequently elected to complete the unexpired term in May, 2013, elected to a full four-year term in 2014 and re-elected to another four-year term in 2018. My accomplishments during my time on city council include: passage of the parks bond to finance the development of Golden Gardens Sports Park; 2017 Road Improvement Bond repairing Bethel streets; advocacy for civil and human rights; West Eugene EmX; and support for the revitalization of the Active Bethel Citizens neighborhood association.

If I am re-elected for a third term, I will continue to pursue viable and impactful solutions for poverty, affordable housing and homelessness, moving our community from fossil fuel dependency to environmentally responsible and sustainable energy sources; meaningful investment in the development and growth of the Bethel area; and making Eugene the most accessible, equitable, and inclusive city in Oregon and America.

We have serious housing crises. There is a lack of affordable housing that has to become a serious priority for this City. In my opinion, there is a lack of creative conversations with those that have the skill, resources and capacity to help ease some of the burdens. I would like to see the churches, entrepreneurs, leaders in this community approached, along with all elements of Team Springfield, County leadership and those at State leadership that it would apply to, bring in the Home Builders Association and ask them all the create a funding pool to help build some housing, different models, that would be a blessing to everyone. Churches are far to guilty of taking every tax free benefit available to them, enriching themselves, while our communities struggle to survive. Giving away recycled clothes, near expired food, and second hand furniture can be a band aid or stop gap, it is not providing a lasting solution. I am not bashing the local faith community. I am a man of faith

and former Pastor. I have two degrees from Christian Universities and currently engaged in completing a third. I just recognize the manner in which faith leaders take, ask for more, keep taking, they give very little back in real service and true giving to those outside of the front doors of their churches. Collectively, they help bring real provision and resources to help address some of the greatest areas of need in Springfield. Are they being approached? Who is willing to spearhead this type of project? I am. If elected, I will undertake this great task for the good of the community as a whole.

LGBTQ rights and protections are a big, big concern to me. We find it far too easy to have a scapegoat here in America. We find it far to easy to label "the enemy" and then deny them of any consideration or protections as human beings. These individuals are part of our community. They are homeowners, renters, employees, entrepreneurs, nurses, doctors, police officers, teachers, moms, dads, family members, friends, tax payers, and the list goes on. We need to recognize their humanity and ensure their voices are heard as well.

I support our local police department. I remember when the Council had members calling for landlords to be fined a \$1000 a day for renting to undocumented individuals, have those undocumented individuals arrested and deported. This perspective had significant support on the council and in the community at that time. I thought we had matured from that perspective. I see that issue has resurfaced especially post the previous administration. Our local elected body has the power to resolve and put an end to these attempts. At one point, during that season, I stood before the city council at the time, with several other Latino leaders to defend ourselves. I actually wept before them trying to encapsulate the pain we were all feeling. Most made a conciliatory statement to us in support. As an elected official in this City, when these attempts are pursued, I will visible and vocally oppose them.

I am sure there will be questions on my candidacy and other positions. I look forward to responding to any and all questions at the scheduled meeting.

#### MINDY SCHLOSSBERG EWEB COMMISSIONER, AT-LARGE



It's hard to believe that I am starting my 4th year on the EWEB Board. I am proud of the work I've done and am especially grateful for the opportunity to serve alongside the other Board members. We have a really well-functioning Board, treat each other respectfully, and offer a good example of how to work together for the greater good.

Some of my accomplishments of note include establishing regular meetings between the EWEB Board and City of Eugene leadership. This relationship did not exist when I started 3 years ago. I initiated this permanent EWEB Board liaison and these quarterly meetings are now ongoing. We are working together on ways to further our climate goals, as well as figuring out how to align other shared interests. I have also helped approve our McKenzie Watershed Recovery and Restoration plan, which invests in ensuring that our water supply and the ecosystems that support it remain healthy. This plan grew out of the tragedy of the Holiday Farm fire and EWEB is committed to help restore the watershed and enhance resiliency. I am proud of the

strategic direction I've given in committing to at least 95% carbon free energy by 2030. The EWEB Board has repeatedly affirmed its commitment to decarbonization and environmentally friendly practices.

There is still a lot more work to be done and, if reelected, I look forward to helping create an integrated resource plan that identifies our energy sources for the upcoming years, establishing a second source for our water supply, developing a meaningful policy to institutionalize equity, diversity, and inclusion, and looking at how to enhance opportunities to collaborate with the City of Eugene to further our shared goals.
